1. The kitten was not allowed direct contact with any other animal.
2. The kitten exhibits signs of illness.
3. The kitten has been examined by a licensed veterinarian and is diagnosed as ill.  
The specific diagnosis and this documentation is returned with the kitten.
4. All related veterinary charges are paid by the purchaser.
5. The purchaser notifies the seller of their intention to return the kitten.
6. The kitten is returned to the seller alive and in good condition.

**Other Conditions:** If, at some time in the future, the buyer is unable to continue to care for this kitten/cat, the seller requests to be notified to assist in re-homing/locating a suitable new owner. Under **NO** circumstances should this kitten/cat be surrendered to a human society or animal rescue facility for adoption or euthanasia.

**The purchaser agrees to the following conditions:**

1. This kitten will not be sold, leased or given to a pet shop or research laboratory
2. This kitten/cat will NOT be declawed
3. This kitten/cat will NEVER be loose outdoors, and will have an adequate indoor litter box

**Food:** This kitten's/cat's diet should NOT be changed: both wet and dry foods are available through Petco and/or Petsmart. (online purchasing IS cheaper through [www.Chewy.com](http://www.Chewy.com))

1. Dry food: Royal Canin kitten up to age 10 months; Royal Canin Sensitive Digestion following
2. Wet food: Wellness Signature Selects- chicken, chicken/beef with 1 tbsp PUMPKIN daily
3. Fish: (salmon or tuna) ONCE a week only!!!! (fish causes diarrhea)
4. Treats: freeze dried chicken ONLY, or Beechnut baby food (chicken or turkey)
5. NO milk products (this causes diarrhea)

**If you change their diet, the one-year health guarantee is null and void!**

**Special Provisions:** The parties to this contract specifically agree to the jurisdiction and venue of the courts of Jefferson County, Missouri, in the event that it becomes necessary to adjudicate any of the rights or actions of the parties hereto. In the event that such litigation is brought, the prevailing party's attorneys' fees shall be paid by the non-prevailing party.
